

## Clinical Committee

### Committee Composition

Chair:	A clinical member of the European Society of Endocrinology, designated by the Executive Committee. The chair does not need to be a member of the ESE Executive Committee.
Full members:	Up to 6 members proposed by the Committee and ratified by the Executive Committee.
Ex-officio members:	ESE President. ESE President-elect. UEMS representative.
Co-opted members:	Up to 2 additional members may be co-opted for a limited period to fulfil a specific role, subject to Executive Committee approval. Input may also be sought from patient support groups.

### Quorum

3 full members.

### Duration of Service

Chair:	4 years.
Full members:	4 years.
Ex-officio members:	Co-terminous with office.
Co-opted members:	Usually two years, but with the option to extend to four years.

### Reporting

The Committee reports to the ESE Executive Committee through the Clinical Committee Chair, if a member of the Executive Committee or, if not, through an ex-officio Executive Committee representative.

### Meetings

At least two meetings per year.

### Remit

1. To advance quality and equality of patient care in endocrinology across Europe (in liaison with UEMS).
2. To support all healthcare professionals (clinicians, specialist nurses and allied professions) delivering patient care.
3. To play a leading role in the development of guidelines for optimal management of endocrine disorders.
4. To give guidance on matters in clinical endocrinology, including ethical issues and best practice.
5. To support clinical research in Europe, with a special focus on supporting endocrinologists in less-advantaged countries.
6. To manage ESE's input into European databases/registries for rare endocrine disorders.

7. To participate in the development and maintenance of audits of endocrine and diabetic practice in Europe.
8. To support the ESE Education Committee on clinical education activities in endocrinology, as required.
9. To liaise with the ESE Science Committee as necessary.
10. To provide input on scientific symposia and other conference and training sessions.
11. To work with the ESE media representative and ESE Office to ensure adequate and appropriate representation of clinical endocrinology in the media.

### **Additional notes**

- Committee members should make every effort to attend all meetings. Any Committee member who does not attend a meeting for a year will be asked to step down, other than in exceptional circumstances.
- All Committee members need to be paid up members of the Society.
- All papers and minutes must be treated in strictest confidence.
- All Committee members must act in the best interest of the Society.
- Any potential conflicts of interest should be declared at the start of the meeting or as they arise, and the member concerned should take no part in the discussion.
- The Chair should not serve a second consecutive term of office, unless there are exceptional circumstances identified by the Executive Committee.
- Committee membership should represent key areas of interest and geographical spread; the Executive Committee should take this into account when nominating Clinical Committee members.
