

ESE: Covid-19 and EU4Health

COVID-19 has inflicted large-scale change and challenges across all sectors and states. Health budgets have been reshuffled and health policy has risen to the top of the agenda like never before. The EU has responded with a variety of actions, including a dedicated COVID-19 funding portal under the European Research Area, and coordination efforts across the continent.

For the 2021-2027 period, the European Commission has proposed a new standalone programme referred to as EU4Health, which intends to make a "significant contribution to the post-COVID-19 recovery by making the EU population healthier, strengthening the resilience of health systems, and promoting innovation in the health sector" and "ensure that EUs health systems are resilient enough to face new and future health threats".

The European Society of Endocrinology has been very active on COVID-19 with a webinar series, statements from the president, a research series in the European Journal of Endocrinology, as well as a comprehensive policy position paper that outlines the links between endocrinology and the pandemic.
