### **Committee Composition**

Chair (Editor) A member of the European Society of Endocrinology, designated by the Executive Committee. The chair does not need to be a member of the ESE Executive Committee.

Full members: Up to 6 members ratified by the Executive Committee including:

EJE Editor-in-Chief, or representative  
EYES Representatives x 2

Ex-officio members: ESE President (Co-Editor)  
ESE President-elect  
ESE CEO

**Quorum** 3 full members (including the Chair)

### **Duration of Service**

Chair: 4 years.

Full members: 4 years.

Ex-officio members: Co-terminous with office.

Co-opted members:

**Reporting** The Committee reports to the ESE Publishing and Communications Committee.

**Meetings** Three meetings per year, one for each issue of *ESE News*.

**Remit**

1. *ESE News* is dedicated to keeping endocrinologists across Europe and beyond up to date with ESE activities and other relevant news.
2. The Newsletter acts as a platform for communication and provides a range of information including feature articles (including regular columns, such as 'Endo Explorer' and 'A day in the life'), society news, ESE committee updates, ECE news and diary/deadline date information

3. The Editorial Board is responsible for the planning of issues and generating ideas for content.

### **Additional notes**

- Committee members should make every effort to attend all meetings. Any Committee member who does not attend a meeting for a year will be asked to step down, other than in exceptional circumstances.
- All Committee members need to be paid up members of the Society.
- All papers and minutes must be treated in strictest confidence.
- All Committee members must act in the best interests of the Society.
- Any potential conflicts of interest should be declared at the start of a meeting or as they arise, and the member concerned should take no part in the relevant area of discussion.
- The Chair should not serve a second consecutive term of office, unless there are exceptional circumstances identified by the Executive Committee.
- Committee membership should represent key areas of interest and geographical spread; the Executive Committee should take this into account when nominating Editorial Board members.
