ECE 2008 A great success for EC European Endocrinology

► The 10th European Congress of Endocrinology, organised jointly by ESE and the German Society of Endocrinology, was held in Berlin from 3–7 May 2008. The ICC was a magnificent venue, and the conference ran smoothly as a result of careful planning. More than 3000 endocrinologists from Europe, as well as from other parts of the world, attended the meeting and acknowledged the high scientific standard of the lectures, symposia and original contributions in their evaluations.

The POC is very grateful to all the speakers who accepted the invitation to contribute to the programme and their efforts are recognised as the main cause for the success of the congress. The

scientific programme included many well attended basic and clinical symposia, covering topics such as: research showing which specific groups of postmenopausal women should be treated with HRT to prevent cardiovascular disease; how a cell is able to sense nutrients through sirtuins and AMPK; reinforcement of the idea that leptin could help obese people to maintain weight loss induced by diet; that both the incidence and prevalence of Grave's disease is decreasing; and new data showing central actions of insulin in the CNS regulate lipogenesis at the peripheral level.

The organisation of the meeting was almost perfect, although the large number of unexpected on site registrations were a challenge to the organising staff. In addition, there was a great contribution from the pharmaceutical industry, both in organising scientific satellites and in the commercial stands.

The weather was beautiful and the attendees enjoyed the visit to the changing places in Berlin and many of them, who had not visited Berlin for some years, were amazed by the many changes that had taken place.

With delegates from 80 different countries, ECE 2008 has been a great success for European and worldwide endocrinology. The ESE and the annual congresses will certainly grow and the spirit and friendly atmosphere of the Berlin meeting will be there again in Istanbul 2009.

ESE remembers John-Frederik Dymling

John-Frederik Dymling, who died last October, was the first President of the European Federation of Endocrine Societies.

John was a Swedish endocrinologist who worked in Malmo. In 1984 he represented the Committee of Acta Endocrinologica Countries (CAES) at the meeting of the European endocrine societies in Quebec, which was called to consider the merits of forming a European society of endocrinology. At that time, the only grouping of European societies was the CAES, which comprised the Scandinavian, German, and Swiss endocrine societies, and they had been reluctant to incorporate into a larger European organisation since they had for many years collaborated successfully in organising congresses and publishing Acta Endocrinologica. At the meeting in Quebec, John was persuaded of the benefits of forming a European grouping of endocrine societies, and later that year he convinced the CAES of these advantages. The consequent support from the CAES opened the door to the formation of a federation, and John was appointed as chairman of a committee representing several European endocrine societies with the brief to plan the first congress and to draw up the constitution. The first congress was held in Copenhagen in 1987, and there the European Federation of Endocrine Societies was inaugurated. John was elected as President, a fitting tribute to his efforts in helping to bring EFES into being.

John was a skilful and effective chairman, with a pleasant personality and faultless command of the English language. Under his chairmanship, EFES started to develop and implement the ideas and policies that formed the basis for the eventual successful conversion into the European Society of Endocrinology.

John lived and worked in Malmo, and was deeply interested in local politics. He was also a very keen golfer, who played off a low handicap, and shared with his wife, Birgit, a great enthusiasm for the game. I shall remember him as an informed, intelligent, and supportive colleague, but particularly as a good friend. VIVIAN JAMES

IMPACT FACTORS

We are pleased to announce the new impact factors for our journals. *The European Journal of Endocrinology* is now at **3.239**, its highest ever value; the *Journal of Endocrinology* is now at **2.636**; *Endocrine-Related Cancer* has been returning strong results for the past few years and this year is **5.193**, and the *Journal of Molecular Endocrinology* is now at **2.801**. Although JOE and JME have returned slightly lower values than previous years, they continue to show keen interest amongst readers and researchers.

The ERCUSYN Project

▶ The ERCUSYN project began when a number of leading European endocrinologists teamed together to apply to the European Union (EU) call under the Public Health Program to set up a European Register on Cushing's Syndrome (the acronym of which is ERCUSYN) and succeeded in being funded for three years.

Establishing a European register will lead to increased knowledge on this syndrome, and consequently to improved treatment and care for patients. The aims of the project include: to increase the awareness among general practitioners or primary care physicians throughout Europe, to make an earlier diagnosis and hopefully improve the long term prognosis and "normalise" the increased morbidity and mortality associated with this syndrome, and to set up European guidelines for the diagnosis and treatment of these patients. Furthermore, special attention will be devoted to evaluating and preventing the impairment in quality of life associated with this syndrome. In order to appreciate the long term impact of Cushing's syndrome on quality of life and mental health, one of the additional objectives of the project is to develop a disease generated tool, the CushingQoL questionnaire, to be available in as many different languages as possible. This will be an important tool to evaluate psychological impairment associated with Cushing's syndrome, even if the patient is biochemically cured.

From the beginning it was clear that this should be a European initiative and currently involves more than 30 colleagues from over 20 countries (see map); the European Society of Endocrinology is also an associated partner, giving a scientific backing to the project and facilitating its extension throughout Europe. Any centre of excellence interested in including new patients into the registry is very welcome, and should register on the project web page www.ercusyn.eu or send an e-mail to the project manager (asantos@ercusyn.eu).

The ERCUSYN web page includes a public area devoted to patients (with brochures translated into as many European languages as possible; your collaboration in translating texts into your own language will be greatly appreciated), and another for the investigators (to collect data from leading endocrine centres on a specially designed database), as well as links to the EU, Orphanet, the Rare Disease Task Force, the European Society of Endocrinology, the Pituitary Society and patient support organisations, among others. He is also Scientific Director of the Erasmus Institute of Neuro-endocrinology (ERINE) in Rotterdam. His areas of research are neuroendocrine disorders,

Low birth weight has been considered a risk factor for developing insulin resistance. This association has been examined further in a study by Rotteveel et al. Four groups of young male adults were compared: 10 born small for gestational age who had been treated with growth hormone therapy, 15 males born prematurely appropriate for gestational age, 13 males born prematurely small for gestational age, and 15 males born at term with normal birth weight. The hyperinsulinaemic-euglycaemic clamp was used to determine insulin sensitivity by peripheral glucose uptake in

the subjects. Insulin sensitivity was found to be lower in all adults born prematurely and in those treated with growth hormone, compared to those born at term with normal birth weight. The study concludes that growth hormone therapy requires careful monitoring in children born prematurely.

ESE Postgraduate course 2008

One spring weekend, when the long winter nights and cold were over, and the sun, albeit shyly, managed to coax plums and sakura into blossom, a high-level meeting on Endocrinology – the 4th Baltic Congress and the 5th ESE Postgraduate Course – took place in Vilnius, Lithuania. The date was 17–19 April 2008. The European Society of Endocrinology and its Lithuanian counterpart, headed by Professor Antanas Norkus, organised a memorable meeting and strong support was provided by Valdis Pirags, Jens Christiansen and John Wass.

Over two hundred participants and lecturers were present, including colleagues from Belarus, Belgium, Denmark, Estonia, France, Germany, Greece, Latvia, Lithuania, The Netherlands, Serbia, Spain, Sweden, Switzerland, Turkey and the UK. The course covered a good combination of basic and clinical science and among the topics were pituitary and adrenal tumours, reproductive endocrinology, thyroid diseases, the genetics of diabetes, insulin action and the treatment of type 2 diabetes, obesity, and the endocrinology of bone and adipose tissue. In addition to 18 excellent lectures the programme included six 'Meet-the-Expert' sessions covering diagnosis and management issues.

One important aspect of the meeting was the opportunity to meet new people, both senior and junior, to hear new ideas and to share results of one's own research. The three Baltic States presented 11 of the newest studies recently conducted in Estonia, Latvia and Lithuania. All this created a good atmosphere of discussions, exchange of ideas and information, as well as better interaction among endocrinologists coming from different European countries.

In our everyday life we often refer to family, friends and work as of the highest importance. I truly believe that our guests, especially the young ones, not only gathered invaluable scientific information but made many new friends. Not just friends with whom to exchange academic knowledge, but simply friends. We often say that friends are like stars: not always easy to reach but very comforting to know that they are around.

The combination of an excellent breadth of scientific information, an amazing city and a warm and genuine people made this meeting a truly memorable one.
